A Message from the Mayor...

Hello to all,

During the past three months since our last newsletter there have been several newsworthy items to report.

This year's Christmas Walk was bigger and better than ever. Our Main Street was beautifully lit for us all to enjoy during the holiday season. From the awesome train displays, to the Nativity with the live animals, to our businesses sharing in the festivities, to the Libraries special program, to the joy of hearing our elementary kids singing, to the awesomeness of our high school music department, to the strolling carolers and on and on we can truly say "The Trains of Williamsburg" brought us the holiday spirit we were looking for.

As we continue to pursue funding for the various projects around the village I can report that we will be receiving grant funding from the Ohio Public Works Commission (OPWC) and through the Ohio Valley Regional Development Commission's Appalachian Regional Commission to be used toward our wastewater treatment plant upgrade. This along with the grant from the Army Corp of Engineers will be a significant step towards funding to complete Phase III of this project. We expect to start construction later this year.

We have also received notification that we have been awarded a Nature Works grant to help fund a second shelter at our Community Park. During the spring, summer and fall months our current shelter is in demand for rental and the 2nd shelter will provide alternatives for use by our community. We are also in the planning stages of strategic tree planting to provide some shade around the seating areas at our playground area. Our park is a great place to spend time in the outdoors and as we strive to maintain it I hope you will do your part should you see abuse or vandalism of our facilities.

As reported in a previous newsletter ODOT has indicated they will be repaving through our village sometime this year. As part of our planning for repaving projects here in the village this year we joined with the County on an OPWC grant application to pave East Main Street to the Brown County Line. It appears this grant is being funded with work to be done before the end of 2016. This County project submitted for OPWC funding will repair and repave Old State Route 32 from Batavia to the Brown County line. We are very appreciative for the opportunity to be a part of that grant application as it will be a huge cost savings for our village.

With the recent news of the County's investment in Williamsburg Township at the Half Acre Road site we all look forward to the economic development opportunities this project will create. As I have always said when something good happens in the village it is a good thing for the township and the same is true when something good happens in the township it is good for the village. We all know that when we say "Williamsburg" we don't think village or township, we think Community!

Free Curbside Brush Collection

The Village acknowledges that brush collection is beneficial service for our residents. However, the volume of curbside brush collection has continued to increase over the past few years and we are trying to streamline the collection process in order to increase our efficiency and services to the community. Residents can help by following the guidelines below:

- Tree limbs and branches must not be over 6 inches in diameter and no longer than 8 feet. Bundled twigs and sticks must be no larger than 8 inches diameter and no higher than 4 feet will be picked up.
- Place tree limb and branch piles at the curb with cut section towards street by 7:00 a.m. on Monday, weather dependent.
- Do not block fire hydrants, sidewalks, or storm drains.
- The Village will not pick up vines, ornamental grasses or building materials.
- Only brush cut by residents can be placed at curb, contractors who do work for residents are required to remove all brush from property.

Your cooperation and patience will insure better service for all residents and assist in more efficient use of Village staff time. If your brush has not been picked up please check your door for a notice left by Public Works staff that will explain what needs to be done for next pick-up.

New Look for Utility Bills

Beginning in March, we are updating the format of our utility bills. Instead of receiving a post card, you will receive a full page letter sized bill in an envelope. This change will make the bill easier to read and will include a graph displaying use history along with additional information. You will be able to remove the bottom part of the bill to return with payment in an envelope provided. We're flushing hydrants!

During the week of April 11th , Village Public Works and Williamsburg Township Emergency Services will be flushing hydrants. This not only helps maintain water quality, but also gives us the opportunity to perform maintenance on the hydrants. It may cause you to have brown water. If you do have brown water, run your faucets for a few minutes to see if it clears. It should, but if it doesn't, please call the Village office and let us know.

With warmer weather coming, there will be more children playing outside. Please take extra care in areas where children could be playing. Pay particular attention in congested areas, where cars are parked along the roads and where views of what lies ahead are obstructed.

The vegetable portion would cost \$500 or about \$25 per week for fresh organic vegetables (tomatoes, green beans, cucumbers, squash, radishes, carrots, beets, greens, peppers (hot and sweet), cabbage, herbs, leeks, onions, kale and more. You also will get stone ground local flour regularly and maybe some other stone ground products. An additional bread option would cost \$120 or about \$6 for any blue oven bread which is a really great deal. It's all going to be grown organically high quality vegetables and bread. 
