



**A RESOLUTION BY THE VILLAGE OF WILLIAMSBURG**

**RESOLUTION: 870-20**

**RESOLUTION AFFIRMING THAT ALL CORONAVIRUS RELIEF FUNDING RECEIVED BY THE VILLAGE OF WILLIAMSBURG SHALL BE EXPENDED ONLY FOR SUCH COSTS PERMITTED UNDER SECTION 5001 OF THE "CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT."**

**WHEREAS**, S.B. 310/ H.B. 481 provides for the distribution of coronavirus relief funds allocated to the State of Ohio from the federal "Coronavirus Aid, Relief, and Economic Security Act" (CARES Act) to eligible subdivisions in the State of Ohio; and

**WHEREAS**, S.B. 310/H.B. 481 establishes a process for distributing funds provided by the CARES Act; and

**WHEREAS**, S.B. 310/H.B. 481 requires, prior to receiving funding, that eligible subdivisions adopt a resolution affirming that the subdivision will spend the funds only on pandemic-related expenses, as required by the CARES Act and any applicable regulations; and

**WHEREAS**, S.B. 310/ H.B. 481 further requires political subdivisions that receive funding to establish a fund in its budget entitled "Local Coronavirus Relief Fund" (Fund 2151) to be used to account for such funds; and

**WHEREAS**, the Village of Williamsburg is requesting its share of funds from the CARES Act;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Williamsburg, Clermont County, Ohio, at least a majority of its members concurring:

**SECTION 1.** That the Village Council hereby affirms that coronavirus relief distributed from the State of Ohio's allocation of CARES Act funding pursuant to S.B. 310/H.B. 481 will only be used for such expenses permitted by Section 5001 of the CARES Act, as described in 42 U.S.C. 801 (formerly 601), and any applicable regulations and guidance only to cover expenses that:

- (1) Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
- (2) Were not accounted for in Williamsburg's most recently approved budget as of March 27, 2020; and
- (3) Were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.


**SECTION 2.** That the Clerk/Treasurer take all necessary action to:


- (1) On or before October 15, 2020, pay any unencumbered balance of money in the Williamsburg local coronavirus relief fund to the County Treasurer;
- (2) On or before December 28, 2020, pay the balance of any money in the Williamsburg's local coronavirus relief fund to the state treasury in the manner prescribed by the Director of the Ohio Office of Budget and Management; and
- (3) Provide any information related to any payments received under S.B. 310/H.B. 481 to the Director of the Ohio Office of Budget and Management as requested.

**SECTION 3.** That the Clerk/Treasurer shall deliver a certified copy of this Resolution to the County Auditor and the Director of Budget and Management.

**SECTION 4.** This Resolution shall take effect at the earliest period allowed by law.

**SECTION 5.** That Village Council hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with all applicable legal requirements including Section 121.22 of the Ohio Revised Code.
