The Clermont County Development Block Grant application for the East Main Sidewalk project was submitted on March 26th to Clermont County Grant Coordinator Sherri Cmar. Clermont County will select the projects in April and Develop the Annual Action plan. The Clermont County Commissioners will approve projects in May.
