

A RESOLUTION BY THE VILLAGE OF WILLIAMSBURG

RESOLUTION 892-21 A RESOLUTION BY THE COUNCIL OF THE VILLAGE OF WILLIAMSBURG TO PROCEED WITH TAX LEVY EXCEEDING THE TEN-MILL LIMITATION

Council for the Village of Williamsburg, Ohio met in regular session this 13 day of May, 2021 with the following members present:

Councilman Maham moved for adoption of the following:

Whereas, on April 8, 2021, Council for the Village of Williamsburg, Ohio passed a resolution declaring the necessity, for the purpose of generating funds to pay the current expenses of the Village of Williamsburg, Ohio; declare taxes within the 10 mill limitation to be insufficient; to levy a renewal of a tax in excess of the ten-mill limitation under RC 5705.19(A) at the rate of five (5.0) mills for each dollar of valuation, for general operating purposes, which amounts to fifty cents (\$0.50) for each one hundred dollars (\$100.00) of valuation for a period of five (5) years beginning with T/Y 2022 and ending with 2026; and

Whereas, the Clermont County Auditor has certified to the Council for the Village of Williamsburg, Ohio that the dollar amount of revenue that would be generated by the tax levy during the first year of collection is \$67,359.00, based on the current assessed valuation of the Village of Williamsburg, Ohio; \$44,122,410.00

Now Therefore Be It Resolved, by the Council of the Village of Williamsburg, Ohio, two-thirds of all members elected thereto concurring, that the Council desires to proceed with the submission of the question of the renewal of a tax levy at the rate of five (5.0) mills for each dollar of valuation, for general operating purposes, which amounts to fifty cents (\$0.50) for each one hundred dollars (\$100.00) of valuation, to the electors of the Village of Williamsburg, Clermont County, Ohio; be it further

Resolved, that the tax levy will be for five (5) years and such levy will include a levy be placed upon the tax lists, commencing T/Y 2022, first due in calendar year 2023, in compliance with Ohio Revised Code Section 5705.34, if a majority of the electors voting thereon vote in favor thereof; be it further

Resolved, the question of such tax levy shall be submitted to the electors of the Village of Williamsburg, Ohio at the election to be held therein on November 2, 2021; be it further

Resolved, that the Clerk is hereby directed to certify, not less than 90 days prior to the election, to the board of elections, Clermont County, Ohio, a copy of Resolution 891-21 and a copy of this resolution together with the certification of the Clermont County Auditor, and notify the board of elections to cause notice of the election on the question of levying the tax be given as required by law.

Resolved, that Council finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting and that all deliberations of Council which resulted in the passage of this Resolution were taken in meetings open to the public, in full compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
