Administrator Ellerhorst reported the Electric Aggregation letters were sent out on June 9th, 2021. The Gas Aggregation vendor selection will take place in the fall and similar opt out letters will be sent out to eligible customers.

Administrator Ellerhorst reported the 2021 Resurfacing Program is scheduled to start at the end of July. The following streets in Williamsburg are including in the 2021 Resurfacing Program: Amber Way, Coral Court, Dawn Court, Happy Lane, Paradise Lane, Rose Lane, and South Eighth Street.

Administrator Ellerhorst reported the Gay Street Phase II construction is scheduled to begin mid-June and completed by November 2021. Materials for the project have been dropped off for the project on the vacant lot on Gay Street.

Administrator Ellerhorst reported the project is still on schedule to begin in July and be completed by August.

Administrator Ellerhorst reported the Nature Works Grant applications have been submitted to ODNR for the playground equipment and the park entrance realignment. Administrator Ellerhorst reported the annual park inspection by the U.S. Army Corp. is scheduled for June 17, 2021.

Administrator Ellerhorst reported the South Broadway and South Fourth Street Sidewalks project documents have been finalized and are ready for the bid process.

Administrator Ellerhorst reported the Wilmar and South Sixth Sewer Lining Project documents are in the final stages to be prepared to bid the project in July.

Administrator Ellerhorst stated the proposed list of streets for the 2022 Resurfacing Program with Clermont County will be due in August. The proposed 2022 Resurfacing Street list was sent out to Councilmembers in May. Administrator Ellerhorst is requesting Village Council's recommendations for streets. Administrator Ellerhorst noted the Public Works Department is recommending reviewing the alleys for the program.

Administrator Ellerhorst reported the Clermont County Port Authority has scheduled dates and times available for Community representatives to meet and discuss projects for the 2022 State Capital Bill process.

Administrator Ellerhorst noted the annual public records shred will be held on June 22, 2021 at the Village Office.

Administrator Ellerhorst reported staff is working on cost estimates for OPWC grant applications due in September.

Administrator Ellerhorst noted Williamsburg Township Junk Days are scheduled for June 10 – June 12, 2021 on Eighth Street.

Councilman Pearcy reported Parks and Recreation Committee met with Scot Conover from Sign Graphics at the Park to determine the location for the sign. The area selected is where the current entrance is located. The sign will be installed temporarily on sight until the entrance realignment is completed.
