Dear Resident or Property Owner:

The Village of Williamsburg, in cooperation with the Ohio Department of Transportation, is currently designing improvements to SR-133/East Main Street between the Little Miami River and the intersection of SR-133. The project will construct a new shared-use path on the south side of East Main Street. The project will provide connectivity for pedestrians and bicyclists between SR133 and downtown Williamsburg improving the safety of pedestrians and bicyclists in this area.

The path will be located entirely within the existing highway easement for SR-133. However, temporary easements may be needed from the adjacent properties to allow for the construction of the path. No property purchases or relocations are necessary. All existing property access will be maintained during construction and afterward. A Right-Of-Way representative of the Village will contact you when definitive information becomes available should the project's design affect your property.

Preliminary plans are attached and available in hard copy or electronically from the Village at the contact information below. Construction for this project is expected to begin in the spring of 2024 and be completed by the fall of 2024. The construction will not require a detour so that vehicular traffic will be maintained at all times on SR-133. Access to properties will be maintained at all times as well.

We welcome your questions and comments. Issues you may wish to comment on include, but are not limited to, the project's effect on residents, businesses, and natural or cultural resources. To ensure your comments may be considered during project development, please submit them no later than February 10, 2023, via the information below:
