AUDIENCE: Kristin Sampsel gave an update on the Farmers Market. She said they are up to 14 vendors and over 100 people attended the last market. The last market of the season will be 10/18 coinciding with the trunk or treat Halloween event.

Liz Betemps gave an update on events for the Garden Club. There is a mum sale currently under way until 9/11. - Chief Timmers stated that the Police department has received their new vehicle. They are now just waiting on the upfitting of the necessary equipment.

PUBLIC WORKS:

ADMINISTRATOR REPORT:

- Water Towers- The Village did secure more money for the Water Tower refurbishment project which should now leave the village with no costs to complete the project.
- Event Permit- Administrator Gephardt presented the permit for the American Legions concert in September. Vice Mayor Maham made a motion to approve. Councilman Mercer second. All Yea by roll call vote. Motion carried.
- CT Consultants- Administrator Gephardt recommended CT Consultants to be the project engineer/manager for the Broadway/Sixth Streets water main and sidewalk replacement project. Councilman Mercer made a motion to approve. Vice Mayor Maham second. All Yea by roll call vote. Motion carried.
- Paving- Administrator Gephardt indicated the paving project went well and completed quickly.

PARKS COMMITTEE:

- The committee was made aware of deed restrictions on land in the park acquired by a Clean Ohio Grant award prohibiting certain developments. This restriction included the construction of a pickleball court. Mayor Lefker indicated she had been in touch with Clermont County Soil and Water on the possibility of trading the restricted land for some land at the wetlands project if the value of the land is of equal or greater value. She will be presenting this idea to their committee in September for approval. Vice Mayor Maham made a motion to approve proceeding with the negotiations. Councilman Herren second. All Yea by roll call vote. Motion carried.
- Abrams foundation is willing to donate \$163,000 for Pickle ball court and a parking lot on this parcel. The location is the north end of the driveway leading to the shelters.
 Councilman Seip made a motion to approve putting the project out to bid. Councilman Collier second. All Yea by roll call vote. Motion carried.

PERSONNEL COMMITTEE:

· Village is still in need of a Court Clerk.

PLANNING COMMITTEE:

 The committee went over a site plan presented by Cross Development for a new Dollar General store located next to the current store with different owners. The committee had some concerns about the current store and issues in that location. They voted on approving the site plan and the vote ended in a tie. Chairman Herren indicated he would be
