



A RESOLUTION BY THE VILLAGE OF WILLIAMSBURG

RESOLUTION: 958 -23

A RESOLUTION STATING THE SERVICES TO BE PROVIDED TO ANNEXED TERRITORY

WHEREAS, a Petition seeking the annexation of 0.792 acres of land situate in Williamsburg Township to the Village of Williamsburg was filed with the Clermont County Board of County Commissioners by Steven Gittinger, Agent and Attorney for Petitioner, James Fatheree, on September 5, 2023; and

WHEREAS, the Village Council of Williamsburg believes that the annexation will serve the general good of the territory to be annexed, and the benefits to the territory and surrounding area will outweigh the detriments, if any, to the territory and surrounding area; and

WHEREAS, Ohio Revised Code Section 709.03(D) requires the legislative authority of the municipal corporation to which annexation is proposed shall adopt an ordinance or resolution stating what services the municipal corporation will provide, and an approximate date by which it will provide them, to the territory proposed for annexation, upon annexation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Williamsburg, Clermont County, Ohio, at least a majority of its members concurring:

SECTION 1. The Council of the Village of Williamsburg states that immediately upon annexation the following services will be provided to the territory to be annexed:

1. Police Protection;
2. Zoning Code;
3. Zoning and Planning Administration;
4. Waste Management;
5. Speed Limit Control;
6. Water and Sewage.

The Village may in its sole discretion, provide additional services to the territory, upon annexation, in addition to those set forth above.

SECTION 2. Should the annexation result in a street or highway being divided or segmented by the boundary line between the Township and the Village so as to create a road maintenance problem, the Village of Williamsburg hereby agrees, as a condition of the annexation, to assume the maintenance of the street highway.

SECTION 3. This Resolution is hereby declared to be an Emergency which must be passed and adopted at once so that it may become effective immediately for the reason that ORC Section 709.03(D) mandates that Village Council, upon receiving Notice of the Hearing on the Annexation, adopt an ordinance or resolution stating what services the Village will provide to the annexed territory upon annexation.

SECTION 4. That the Village Clerk is hereby directed to certify a copy of this Resolution to the Board of Commissioners of Clermont County.

SECTION 5. That it is hereby found and determined that all formal actions of this Village Council concerning and relating to the passage of this Resolution were taken in an open meeting, and that all deliberations of this Village Council and any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code; and

SECTION 8. That this Resolution shall be effective at the earliest date allowed by law.
